#### 15. AOB

(i) Hugh Kirkbride reported on the takeover bid of GKN, the UK's third largest FTSE-100 engineering company – behind BAE Systems and Rolls-Royce. It employs 59,000 staff, with 6,000 in the UK by Melrose, an asset-stripper which break firms up and sells them. Trades Unions fear that many highly skilled jobs in Aerospace and the Automobile Industry will be destroyed by a few corporate vultures plundering a company for short-term profits but long-term disaster.

Agreed to support GKN workers in their campaign to prevent this takeover.

- (ii) It was reported that Facility workers employed at Southmead Hospital had fought of plans to privatise their jobs.
- (iii) Bristol City Council employees have had their Redundancy pay reduced by 50%. It was agreed to write to the Joint Trade Committee inviting speakers from the 3 main TUs to one of our meetings.
- (iv) There are proposals to reduce the Budget in South Gloucestershire by £34 million.
