# **50/19 REPORTS**

(i) SWTUC Executive

Simon Crew reported on a recent meeting he had attended where the following were discussed;

- ☐ Future Leaders and Young Workers Group event to be held on 7<sup>th</sup>. November
- Living Wage campaign Bristol Mayor seeking to make Bristol the first Living Wage City in the country however outsourcing an issue. Aiming to create Living Wage Zones eg. Temple Meads area development with the University of Bristol.
- $\ensuremath{\mathbb{I}}$  Dying to Work Campaign Some Health Trusts have signed up.
- TUCJCC Representative reported that the Trades Union Councils' Motion to Congress giving Trades Councils a bigger voice at Congress was defeated due to major unions not supporting.

Airport Consultative Committee – Airport has a Carbon Neutral aim.

- Going Green Climate Change Strikes. TUC had supported the recent action however some committee members felt that the TUC needed to reach out to the climate change activists as it appears many of our policies are contradictory with their aims.
- UOB Court. SWTUC has appointed a delegate
- ☐ Trade Unions' Campaigns CWU reported that Royal Mail Postal Workers are being balloted for Industrial Action.
- Various Trade Unions reported on their campaigns.

Arising from the report the USDAW delegate reported that the Co-op are changing Contracts for new starts to include Saturday and Sunday working along with changes to Pensions. He also reported that the company has in-house trainers and this has resulted in a 20% increase in TU membership. It appears that Supermarkets are attacking the terms and Conditions of employment of their staff in response to competition from Aldi and Lidl supermarket chains.

It was agreed to invite a speaker from the CWU regarding their anticipated industrial action.

With regard to the Climate Change strikes;

Simon Crew reported that he had attended one at his daughter's school. The Children's Demo received a good response from the public, including motorists at the initial stages. It was reported that 10,000 people participated.

A Unite delegate, with regard to Carbon Free issues, reported that the Council wishes to remove all Gas appliances for cooking from their High Rise properties and replace with Electric which is 50% more expensive. In addition, H&S statistics show that more fires are caused by electric cookers.

An NUJ delegate was of the opinion that Parking Zones and the potential banning of Cars etc within the City could be discriminatory especially with regard to trades people etc who rely on their own transport to carry out their business within the city.

A PCS delegate said that there is a serious air pollution in Bristol resulting in 300 deaths per year and that there is a need to look at other solutions eg free public transport linked to an integrated transport system.
