(i) SWRTUC meeting with Marvin Rees, Bristol Mayor held on 28<sup>th</sup>. January 2020

Hugh Kirkbride reported the following matters were discussed;

Living Wage Campaign. Major employers are objecting to having to pay for registration and scrutiny, campaign does not cover sub-contractors and it appears the campaign is struggling. Hugh reminded the meeting that Collective Bargaining was essential.

The Living Wage Quarter will be based around Temple Meads but what about outside of this area?

- Bristol Airport expansion. Mayor was seeking a statement of support from the SW TUC to go to a Planning Committee meeting at the end of February which will be discussed at the next meeting of the SWTUC Executive.
- Mayoral Election. It was hoped that the SWRTUC will have an input into the Manifesto.

Bristol Airport Expansion – Supportive Statement

Following discussion where a number of Trades Unions including Unite and GMB were in favour and PCS and ASLEF amongst those against, a vote was taken with the following result 6 for, 6 against, 6 abstentions. The Vice Chair (PCS) used the casting vote against a supportive statement.

- PCS campaign against tax office closures, Unison and RCN Strike action in the North of Ireland, FBU against cut backs in Crew members by the Devon and Somerset Fire Authorities
